- Head north on I-25 to Santa Fe - 45.2 miles
- Take exit 278 for NM-14 N/Cerrillos Road - 0.9 miles
- Merge onto Cerrillos Road/El Camino Real/NM-14 N, Continue to follow Cerrillos Road/NM-14 N - 4.3 miles
- Turn right at Camino Carlos Rey 0.2 miles
- Turn left to State Library parking lot

From Espanola and Los Alamos

- Head south on I-25 to Santa Fe – 15 miles from Pojoaque
- Turn right on Cerrillos Road – 3.5 miles
- Turn left on Camino Carlos Rey 0.2 miles
- Turn left to State Library parking lot

From Las Vegas

- Head south on I-25 to Santa Fe – 70 miles
- Turn right on Old Pecos Trail – 5 miles, Old Pecos Trail veers to the right, continue heading west on St. Michaels Drive
- Turn left on Cerrillos Road – 1.5 miles
- Turn left on Camino Carlos Rey 0.2 miles
- Turn left to State Library parking lot
